

TERMS OF USE AND PRIVACY

Welcome to the Website of C.L.I.C. Community of Leaders Innovating in Corporations at www.clic-challenge.ca (the "Website") operated by Alter'Inno Conseil ("Alter'Inno"), an incorporated company under Quebec law. The Website offers activities and contests to users ("you") who wish to make their expertise known to new contacts.

By using this Website or any of its features, you acknowledge that you have read, understood and agreed to be bound by these Terms of use and the legal privacy framework described below ("Terms of Use"). If you do not wish to accept these Terms of Use, please discontinue all use of the Website and its features. Alter'Inno may change these Terms of Use at any time without prior notice from Alter'Inno. It is your responsibility to familiarize yourself with any changes.

(1) Permission Granted to the User and Intellectual Property

You are invited to participate in the activities and contests on the Website for free, but you may be awarded a prize or prizes if your project is selected according to the relevant contest rules (see [Contest Rules](#) for details). Alter'Inno may provide certain information based on your use of the Website or participation in a contest, including information, data, documents, trademarks, logos, or other items that may assist you in using the Website ("Alter'Inno Content"). Alter'Inno Content may not be used for any purpose other than use of the Website or participation in a contest offered on the Website. Alter'Inno Content is protected by intellectual property law. Alter'Inno Content is owned by Alter'Inno or used under license. Nothing herein shall be construed as granting you any license or intellectual property rights regarding Alter'Inno Content. Any use, reproduction, dissemination, publication or retransmission of Alter'Inno Content, in whole or in part, in any form, is strictly prohibited without Alter'Inno's prior written permission.

(2) Your Content

This Website requires registration, information and documents ("Your Content") to enter a contest. If you choose to provide Your Content, you agree that you will promptly provide up-to-date information to ensure its accuracy and completeness. You acknowledge that you are responsible for (i) maintaining the confidentiality of your chosen passwords; (ii) any activity carried out under your username or password; and (iii) quitting your account at the end of each session. By providing this information, you grant Alter'Inno the right to use Your Content to compile and edit aggregate statistics, in particular about technology, participants, founders and investors, with a view to monitoring these people and tracking trends in the types of projects filed.

Due to the large quantity of information and documents received by Alter'Inno and the similarity of much of the information provided, Alter'Inno cannot accept any responsibility for misuse of Your Content or for disclosure of any general information, knowledge or other documents (including without limitation any information that is well known in the industry and specific to you) included or provided in Your Content. General information of this kind submitted to Alter'Inno may be used or disclosed by Alter'Inno or any other person with whom Alter'Inno shares the application.

(3) Use of Personal Details

Your personal details, i.e. any information about you as a natural person that allows you to be identified, such as your name, home address, personal email address, home or personal cell phone number, date of birth ("Personal Details"), are valuable. By collecting this information, Alter'Inno is able to provide products and services of interest to you and to respond promptly and adequately to your needs. In particular, the Personal Details collected allow us, with your consent, to send you electronic documentation in the form of a newsletter containing Alter'Inno contest updates, and to respond to requests for information. Alter'Inno will not disclose Personal Details collected in this way to a third party except where provided by law. If you are under 18 years of age, please do not send us any Personal Details.

(4) Verifications, Comments or Complaints

Subject to legal conditions and exceptions, you may request to view, correct or delete any Personal Details about you as held by Alter'Inno. For all verifications, comments or complaints, write to hello@alterinno.com and include relevant information that will allow us to identify you.

(5) Information Collected Automatically

When you access the Website, information is automatically exchanged between your computer, the Website server and the servers of Google Analytics, a third party that produces traffic statistics for the Website. Information exchanged with Google Analytics servers includes: (i) the Internet service provider's domain name and your IP address; (ii) the type of browser and operating system used to access the Website; (iii) the date and time of access to the Website; (iv) the Website pages visited; and (v) the address of the website of origin. This information exchange is necessary for the Website to function correctly. The information is kept for statistical purposes. It is also stored in data logs for security reasons and for producing traffic statistics for the Website. The information contained in these logs may be shared with third parties in the event of security audits or law enforcement investigations. It is not used for any other purpose.

(6) Cookies

A cookie is a small text file sent by a website to the user's web browser. It serves as a reminder of your preferences, improves communication between our server and your browser and makes your next site visit more efficient. It may also be used for advertising purposes. Use of cookies is common practice. Most major sites use cookies to better communicate with their users. One or more cookies may be stored on the hard drive of the computer you use to navigate on the Website. Cookies sent from the Website are not intended to identify you or exploit personally identifiable information about you.
